About the test:

- The test is on paper with no time limit.
- All tests are multiple choice. Core is 50 questions and most other tests are 35 questions.
- Calculator is allowed. The tester will be given scratch paper and a pencil.
- Retesting/Tester cannot retest the same test in the same day. Also, the 3O and 3OT cannot be taken on the same day.

Accommodations:

 The tester needs to contact the Bureau Chief at 515-281-8591 and request accommodation. Tester will need to provide documentation of the accommodation needed. The Department of Agriculture will approve or deny the accommodation request.

After the test:

- After a passing score, the Testing Center will complete the Verification of Commercial or Private Applicator Certification form for your records.
- Apply for certification on the Self-Service Portal for License and Registration: https://iowaagriculture.force.com/pesticideapplicator/s/login/
- A pesticide applicator certification is not active until all paperwork and fees are in possession of IDALS.
